## The Challenge

---

Today's banking environment is a complex one: cybersecurity threats are constantly emerging; the way that institutions manage their sensitive customer data is continually evolving; more and more third parties are involved in storing and processing data; and regulators continue to update guidance and reporting requirements. Having an effective **information security officer (ISO)** within the institution to manage these challenges has become essential. However, community bank ISOs often struggle to keep up with the growing number of responsibilities this role requires – often forced to manage critical tasks with limited resources and a lack of segregation of duties.

Nicole Rinehart, former chief operations officer at American Pride Bank, ran into this very issue as the **sole IT admin** at American Pride Bank. Managing all of the ISO responsibilities, including critical activities such as Board reporting and the production of comprehensive reports for examiners, was difficult to manage due to the many manual processes required.

"As a small bank, we couldn't justify hiring another staff member to help us segregate the ISO duties at the time," said John Hall, CEO and president at American Pride Bank. "We needed to identify a more robust process internally to **meet regulatory requirements** and monitor our ISO activities to ensure they were completed accurately and efficiently."

During a regulatory examination, the examiner recommended the bank focus on having more independence within its ISO duties. The Federal Financial Institution Examination Council (FFIEC) also states that all financial institutions must have **separation of duties** for the ISO role. To accomplish this, the bank began evaluating solutions to help streamline processes and ensure complete oversight of all information security activities.

"After our exam, we knew we needed some support to ensure all ISO responsibilities were managed efficiently," said Rinehart. "We needed a solution to help us streamline manual processes, closely monitor ISO duties, identify areas of risk, and effectively report on the entire process."

## The Solution

---

While attending Safe Systems' NetConnect Customer Success Conference, Rinehart was introduced to the **ISOversight™ virtual ISO (VISO) solution**, which provides a software as a service (SaaS) bundle of compliance applications and extensive compliance knowledge to augment the ISO role. The solution includes:

- **audit management**
- **business continuity planning**
- **a cybersecurity assessment tool**
- **vendor management applications**
- **and an information security program**

These features were designed to help financial institutions cover the areas ISOs are required to oversee as outlined by the FFIEC's **IT Examination Handbook**.

After careful evaluation, American Pride Bank decided to partner with Safe Systems to support its VISO initiatives. The bank was already leveraging Safe Systems' Cybersecurity RADAR™, BCP Blueprint™, and Vendor Management applications, and with an additional audit management tool and full information security program, the complete solution rolled all of the bank's key information into one centralized location for easy monitoring and reporting.

## The Results

---

With ISOversight, American Pride Bank has improved its overall preparation and communication of the information security program. All key stakeholders in the bank have access to ISO-related items in real-time, and the information security program is **more organized and streamlined**, enabling the bank to save time on monitoring and reporting.

“In the past, Nicole had to pull from different portals to gather spreadsheets and other documents, and now all important information is in **one centralized location**, where everyone can monitor and be more engaged with the program,” said John. “With this solution, the oversight of the ISO duties is no longer an issue, and puts processes in place to add the separation of duties required in the FFIEC guidelines.”

With comprehensive detailed reporting, the bank has realized a more than 50%-time savings in terms of manual processes. Previously, pulling reports for the Board, senior management, examiners and auditors took five to seven days to complete, but with ISOversight, the time has decreased to just two days. The solution has also made **managing policies** incredibly easy for the bank. Safe Systems makes the policy changes as soon as a new policy comes out, so bank staff doesn't have to worry about updating this information to maintain compliance.

“The ISOversight solution has been a game changer for our bank because now we have a robust process in place working with Safe Systems and a full committee of our team members to ensure all tasks are completed accurately and nothing slips through the cracks,” said Rinehart. “It's so important to have a process like this, especially when you have limited resources.
